

## Declarations for Candidacy – VI Republican Caucus – March 10, 2012

Rules 3 and 6 of the Rules of the Virgin Islands Republican Caucus read as follows:

3. **Eligibility to Participate in the Caucus:** Participation in the caucus shall be limited to persons domiciled in and registered to vote in the United States Virgin Islands and being officially registered in the Republican Party in accordance with Title 18 of the Virgin Islands Code.

6. **Delegate Candidates – Pledged and Uncommitted Delegates:** Candidates for election as Delegates and Alternates (“Delegate Candidates”) must meet the eligibility requirements of participation in the caucus as set forth in Section 3, above, and shall be those persons having declared their candidacy by submission of a written declaration of candidacy to the Executive Director of the VIGOP received by the Executive Director no later than 5:00 p.m. on February 10, 2012. No special form of declaration shall be required except that such declaration shall bear the signature and include the name, address and telephone number of the declarant and the name (if applicable) of the candidate for the Republican nomination for President of the United States to which he or she shall be pledged. If no such person is named, such Delegate Candidate shall be deemed to be uncommitted. Delegate Candidates that declare as being pledged shall be deemed to have promised, if elected, to vote for such declared candidate for the Republican nomination for President of the United States on the first ballot of the Republican National Convention. Delegate Candidates who have so declared, but whose declared candidate for the Republican nomination has withdrawn his or her candidacy prior to the Caucus Date shall be deemed uncommitted. (emphasis added).

For purposes of declaring one’s candidacy as a delegate to the 2012 Republican National Convention to be held in Tampa Florida during August 27-30, 2012, completion and submission of the attached form will suffice. Declarations of Candidacy, **including a photocopy of current Virgin Islands voter’s identification showing Republican registration**, using the attached format or otherwise, should be mailed, faxed, or emailed to:
